

Minutes of the 1266th Meeting of the Manchester  
Pickwick Club held at the Moorside Social Club on  
15<sup>th</sup> February, 2023

After the delayed start to the last meeting due to the late arrival of the vice-chairman (which he insisted wasn't his fault), the 1266<sup>th</sup> meeting of the club was also delayed due to the absence of Pickwick himself when members were advised that Pickwick's lady friend had broken her leg in an accident and needed assistance.
