

MANCHESTER PICKWICK CLUB

Meeting No. 1002 — 17/11/77

Headquarters: Egerton Arms

Item 1 - The meeting was brought to order by Nat Winkle acting as Mr. Pickwick, with Mr. Pott acting as Vice. Before admitting guests to the meeting, a new member was initiated into this confraternity of hearty good fellows; Mr. Justice Stareleigh is his name, and he was welcomed in the usual Pickwickian manner.
