

## Minutes of the 1085th meeting of the Manchester Pickwick Club held at the Black Horse Hotel on 17th January, 1991

The 1085th meeting of the Manchester Pickwick Club was preceded by a discussion between Jinks (who was once again standing in for Pickwick) and the Secretary about which agenda to use for the members only meeting. It was quite obvious that the Secretary had failed to bring the correct agendas and was trying to palm Pickwick off with an agenda for Dingley Dell; Pickwick, being a stickler for procedural etiquette, was refusing to accept the wrong agenda but was meeting resistance because it was simply impossible to produce the correct agenda. Eventually a compromise was reached whereby the meeting used the agenda normally associated with ordinary meetings.

Honour having been satisfied, Pickwick proceeded to break a chair and having replaced it, sat down to commence the meeting only to disappear through a hole in the floor – the smile on the secretary's face showed how the power of prayer is sometimes answered in mysterious ways!

The minutes of the last meeting were read and approved, after which members were updated on the incident of the 3d bit which had been claimed by Dubbley but subsequently rejected by him following examination. After some discussion it was agreed that the venue for both events should be the Grants Arms, the suggested dates being 7th June and 6th or 13th December, It was further agreed that a Ladies Evening be held at the Park Hotel, Prestwich, if possible on 1st November.

Dubbley reported that he had lost his badge and asked whether any were available. Following comments about the appearance of the last badges, Dodson agreed to ask Tadger to make enquiries about replacements.

Grummer proposed a toast to British troops serving in the Gulf; this was supported unanimously.

Dodson, whilst selecting a reading for the POR & I, had found a passage where Sam Weller refers to Dodson and Fogg as virtuous gentlemen, and cited this as further proof of his qualities. Mivins pointed out that the same Sam Weller also reported Dodson

for failing to attend a meeting on his return from Spain but Dodson claimed that particular offence took place 90 years after the book was written and that 90 years before, they were virtuous.

The 9.00 pm. toast was taken at 10.50 pm, after which the raffle was held. Jingle won a bottle of window cleaner which so amused Pickwick that he promptly rocked back on his chair and once again disappeared through the hole in the floor. On being restored to the meeting he examined the agenda and announced that he thought he had gone through everything – and wondered why everybody laughed.

Seconding the vote of thanks, Pell said it was the worst meeting he had ever attended and that both Pickwick and the vice chairman had made a mess of everything they had attempted. Despite this, he was pleased to second the vote of thanks, if only to end the meeting that much quicker.

Pickwick responded by referring to the old show business saying "never try to follow children or dumb animals" and refusing to say any more.

"Good neet owd friends" was led by Stiggins and Nupkins and followed by the National Anthem.

The fines Box contained £5.10, whilst the raffle raised £2.40.
