

**Minutes of the 1196th Meeting of the
Manchester Pickwick Club
held at the Moorside Social Club on 17th September, 2009**

The 1196th meeting of the Manchester Pickwick Club commenced at 8.04 p.m. with Dodson circulating the table collecting money as usual.

The toast to Mr Pickwick was sung and it was suggested that the quantity of the singing was good although the quality left a little to be desired.

Tadger volunteered to act as POC and immediately cadged a sheet of paper on which to record the drinks order, unlike his predecessor, Ben Allen who not only cadged paper but also a pen to write with! The order having been taken, Tupman apologised for Weller who was in Spain; he reported that when Dodson was in hospital for a hernia operation recently, Weller had mistakenly assumed it was to have his wallet lanced when, in fact, everybody knew Dodson was having his wallet pocket stitched up and a padlock fitted!

With the placing of the drinks order Smangle produced a sort of loyalty card which was issued to regulars at the Moorside club and allowed a reduction in drinks prices – Dodson immediately claimed that this sort of card should belong to the Pickwick club rather than the individual because it was club money which had purchased the drinks in the first place so any benefit should accrue to the club.

At this point in the proceedings Winkle's mobile phone rang so he incurred the first fine of the evening, closely followed by Dodson who Pickwick accused of trying to take over the meeting.

A further communication of direct concern to this club was a letter from the Secretary of the Moorside club indicating that on Thursday evenings the upstairs lounge would no longer be available for meetings of this club. After considerable discussion involving inspection of the alternative room suggested by the Moorside club, members agreed that the alternative room suggested for Thursday evenings wasn't suitable and Grummer was asked to speak to the steward to see if the upstairs lounge was available on Wednesdays. Grummer was told that Wednesdays were fine and

members agreed that a formal letter should be sent by the Secretary to his counterpart at the Moorside club asking that the upstairs lounge be made available to this club on the third Wednesday evening in each appropriate month.

Jingle asked that the Secretary write to Mrs Jingle notifying her of the change of meeting dates so she could make alternative arrangements for the soirees she normally hosts when Jingle is attending Pickwick meetings, otherwise he would be forced to roam the streets until all her guests had gone home!

The vice-chairman had done little to help the floundering chairman and the whole performance by both Chairman and his vice-chairman was as tarnished as the badge of office Pickwick wore round his neck.

Seconding the vote of thanks, Winkle said he didn't agree with Grummer but accepted that things could have been better had Pickwick been aware of what was going on. Similarly, Tadger had volunteered to act as POC but had been forced to bring the drinks up by hand because the drinks tray wasn't available – the former POC who now occupied the vice-chairman's position should have foreseen this possibility and made sure the tray was available.

Pickwick thanked both members for their kind words and said this was the most difficult meeting he had chaired.

'Good neet owd friends' was sung by all and followed by the National Anthem.

The raffle raised £8.50 whilst the Fines Box contained £9.09.
