

Minutes of the 1253rd meeting of the Manchester Pickwick Club held at the Moorside Social Club on 20th March, 2019

The 1253rd meeting of the Manchester Pickwick Club was quite well attended and was opened promptly at 20.00 hours with Ben Allen volunteering to act as P.O.C.

Noting that, once again, there were no guests, it was suggested that greater effort should be made to bring more people to the club, the main recruitment area for the club being former guests as witnessed by the recent influx of younger members. Jingle said the last guest he had brought was currently in prison but modified that comment by explaining that he worked there!

Roker suggested that the AGM could be held at Styal prison so that Jingle's guest could attend but on being told that Styal was a women's prison said that was his intention when he made the suggestion.

Comment was then made about the deficiencies in the ability of the P.O.C. to anticipate the liquid requirements of members, Grummer likening it to his time in the desert and rule 8 was invoked so that the appropriate refreshments could be obtained.

Two boats were required and the chosen date was 9th August. The boats would leave the Moorings at 10.00 hours and head towards Leigh, returning by 16.30.

The Summer Outing would be at Curley's on 14th June, with transport leaving the Red Lion in Swinton at 19.00 hours.
